Enclosed herewith please find a copy of the "Recommended Order" from the Family Law Master regarding Kurt's case. As you can, we succeeded in convincing the Court that a transfer of custody is in Kirstan's best interests. In particular, I direct your attention to Findings of Fact Nos. 26, 27, 28, 29 (including subparts) and 30. Those Findings discuss your opinions and testimony offered at the hearing. In finding No. 30, the Judge concludes with the following sentence: "The Court finds Dr. Weinstein to be a very credible witness." I agree.
