Dear Dr. Monty:

Needless to say, the complexion of my case changed after that. I went from losing my child to having her 50% of the time! My daughter and I were truly blessed.


Without hesitation, I can say that without Dr. Weinstein, I would have lost my child, she would be living in another state and I might have been able to see her once a month for a weekend.
